The bids must be submitted within 30 days of date of announcement of public invitation for bids, that is, till January 22th, 2015, by 10.00 h.

Place, time and method of bid opening

The public opening of bids will take place at the premisses of the CLINICAL CENTER OF SERBIA – Great Hall, Administrative building, Pasterova 2, 11000 Belgrade. The bids shall be opened immediately after expiry of deadline for submission of bids, that is, on the same day - January 22th, 2015, at 10.30 h

Conditions under which bidders' representatives may participate in bid opening procedure:

Bids may be submitted by all interested legal or natural persons performing the activities which are the subject of the public procurement, pursuant to the Law

Deadline for adoption of the decision	The decision on contract award shall be brought up to 25 days as of bid opening, except in exceptional, justifiable cases, such as extensiveness of bids or complexity of bids, that is, complexity of weight deriving methodology, when the deadline may be extended to 40 days as of bid opening
